

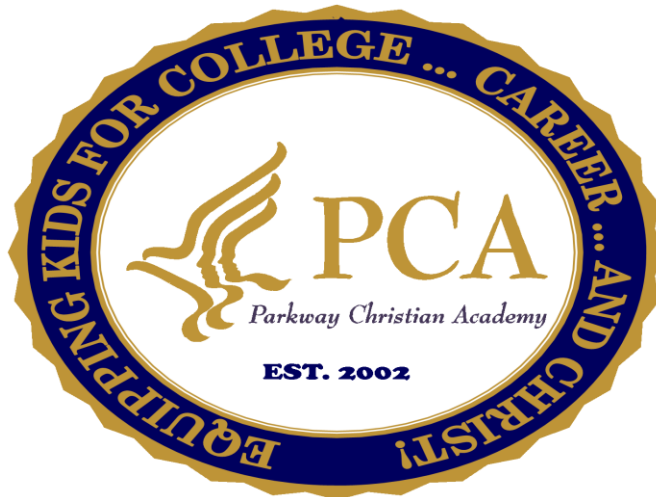

IV. COMPLIANCE AGREEMENT

No person shall be denied enrollment, excluded from participation in, be denied the benefit of or subject to discrimination in any program or activity, on the basis of sex, race, color, national origin or ethnic group. For the safety and well-being of our students and employees, students or employees with a life-threatening communicable disease may not attend or work at PCA. Decisions regarding attendance or employment will take into account multiple medical professionals with expertise in the disease. As a Bible-based educational institution, PCA adheres to the Biblical teaching that homosexuality is not an acceptable lifestyle. PCA does not employ teachers or accept students who are homosexual or bi-sexual.

1. Parents will pay tuition as stated by PCA Tuition Contract. All transcripts and final report cards will be held until the account is paid in full. (Health records will be released upon request). **Should a student withdraw, the family may be financially responsible through the current semester or for the entire school year.**
2. We sincerely pledge our loyalty to the aims and ideals of the school and will bring all questions and criticisms directly to the administration so that they may be properly considered by those in authority.
3. The faculty and administration are hereby given full discretion in the discipline of your child (ren). This would include the issuing of after school detentions, restriction in after school activities, special workdays, or suspensions. Parents will be notified of any disciplinary measures.
4. The school reserves the right to dismiss who does not cooperate with the educational process. PCA students are expected to abide by the standards and policies of our school both on and off campus. If dismissed, students may not be considered for re-admittance until the following school year.
5. Students new to PCA and those returning after withdrawal are accepted on a probationary basis for the first nine weeks of attendance.
6. I give my child (ren) permission to participate in school activities, including sports and school sponsored trips and absolve the school from liability to me or my child (ren) because of any injury to my child (ren) at school or school activity. In case of accident or serious illness, I request the school to contact me. If the school is unable to reach me, I hereby authorize the school to make whatever arrangements deemed necessary.
7. Parkway Christian Academy does not provide accident or supplemental insurance for students. All International students must purchase their own medical insurance policy that is rated for international students. **All students must show proof of insurance in order to gain admittance to PCA.** The policy should be purchased on a 10 month basis from August to May. Proof of insurance must be on hand each day of attendance.
8. I give permission for the school nurse to release medical information to teachers and administrators. The nurse may also request and receive medical information from my child's physician.
9. I hereby grant PCA to use my son or daughter's photograph in print, electronic or video formats, or in other official PCA print publications and I acknowledge PCA's right to appropriately crop and/or correct the photograph as needed.
10. PCA has the right to reproduce, use, exhibit, display, broadcast, distribute and create derivative works of the photographed images of your son or daughter for use in connection with the activities of PCA for promoting, advertising, publicizing, or explaining PCA or its activities.
11. We have read in its entirety the Compliance Agreement, Statement of Cooperation, Parent/Student Handbook, Mission Statement and Vision and are in full agreement as so stated.
